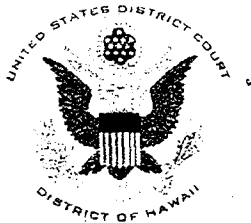
1) ORDER VACATING THE AUGUST 3, 2009 ORDER ADOPTING FINDINGS
